

## CUSTOMER APPLICATION FORM

*This Program offers financial incentives for the purchase of energy-efficient equipment. To qualify for a rebate, an applicant must meet the following requirements:*

- Applicants must be Perham Natural Gas customers where the equipment is being installed.
- A final invoice for all material, including Manufacturer name, Model number, efficiency rating and labor related to the installation must be attached to this rebate application.
- Equipment installations must meet minimum efficiency requirements as shown in the Minimum Efficiency Requirement table below to qualify for a rebate.
- The equipment must be purchased and installed within six (6) months of application for rebate.
- **Rebate applications will be processed on a first-come, first-served basis. Funds are limited.**
- Rebates will be paid directly to the applicant.
- Maximum of 4 units/year/location.
- Renters may apply provided they have written authorization from the property owner.
