WHAT IS INSULATION?

Insulation is any material that resists the flow of heat from one surface to another. Insulation retards the rate of heat escaping from the house in the winter and entering in the summer. Home insulation is available in blankets, batts, pouring wool, and blowing wool. Insulation is measured in R-Values, the higher the value the better. Look directly on the insulation for the R-value. One brand of insulation batts might be slightly thicker than another, but if both show the same R-value they'll perform equally.

Most homes are poorly insulated and in most cases the existing insulation can easily be improved.

- Ceiling/Attic R-44, minimum
- Wood Framed Wall R-19, minimum
- Floors R-30, minimum

DID YOU KNOW?

- ⇒ You can reduce your energy cost by up to 30% with proper insulation and air sealing.
- ⇒ One of the most cost-effective ways to make your home more comfortable year-round is to add insulation to your attic.
- ⇒ Crawl spaces, walls and floors above the crawl space should be insulated.
- ⇒ Weatherstrip your attic door. If there is a 1/4 in. crack under the door, you will lose about \$5 worth of heat every winter.
- ⇒ Attic and crawl space ventilation is necessary and very important both for winter heating and summer cooling.

General Terms and Conditions

This program offers financial incentives for the purchase of R-Valued insulation. To qualify for a rebate, an applicant must meet the following eligibility requirements:

- Applicant must be a Perham Natural Gas customer where the insulation is being installed.
- A final invoice for all material and labor must be attached to this rebate application.
- The insulation must be installed within twelve (12) months of application for rebate.
- Rebates will be paid directly to the applicant.
- To avoid delay, the invoice that is returned with your rebate application must include the R-Value and square feet of insulation purchased and installed.
- Maximum \$500.00 rebate per location per year.
- Renters may apply provided they have written authorization from the property owner.
